Deadlines for clubs/licensors in order to submit the required club monitoring information to the UEFA Administration via the CL/FFP IT Solution are the following [Article 54 (2d) UEFA CL&FFP Regulations] :

15 July 2014	ightarrow Scope: All clubs participating in the 2014/15 UEFA club competitions.
	"CI - 2014.01" package covering the club/legal information for reporting periods ending in 2012 (T-2), 2013 (T-1) and 2014 (T);
	"OP - 2014.06" package covering no overdue payables information as at 30 June 2014 including Transfer, Employee and Social/tax payables; and
	"BE - 2014.06" package covering break-even information for the reporting period ending in 2012 (T-2) and 2013 (T-1).
15 Oct 2014 (if applicable)	→ <u>Scope</u> : All clubs participating in the 2014/15 UEFA club competitions which are in breach of an indicator or if otherwise requested by the CFCB-IC.
