UEFA Club Licensing – 2020/21 Key Deadlines

Dear Licensing Managers,

In order to assist you throughout the 2020/21 season please find enclosed the overview of the club licensing deadlines that will need to be respected during the next 12 months.

In particular it should be noted that the submission of the 2021 licensing decisions for the participation in the 2021/22 UEFA club competitions (men's and women's competitions) has been set for 31 May 2021. Therefore, as always please take this into account when defining your core process in accordance with Article 9 of the UEFA Club Licensing and Financial Fair Play Regulations (CL&FFP).

In this respect it should also be noted that as part of the admission procedure for entering the 2021/22 UEFA club competitions, the entire club licensing core process needs to be finalised by the deadline for the submission of the list of licensing decisions to the UEFA administration and any decision communicated after this deadline cannot be taken into account.
